The budget system is a set of state, administrative-territorial structures, state organizations and funds that are independent in budgetary relations, based on economic relations, state structure and legal norms. The budget system is the main link in the state financial system.

State budget and local budget. Local budgets are of great importance in the implementation of state economic and social tasks, primarily in the distribution of state funds and the development of social infrastructure. They are a financial source for the activities of local authorities and play a key role in the implementation of the state's social policy in the regions. During the period of independence of the Republic of Uzbekistan and its transition to a socially oriented market economy, the role of the budget and local budgets in the socio-economic development of the republic has increased. In order to provide social protection to the population, a large amount of funds are required from the budget, and these funds are provided by local budgets.
