Abstract: The current article explores the return of "To Kill a Mockingbird" (1960) by American novelist Harper Lee, in "Jasper Jones" by Australian writer Craig Silvey (2009). The two novels are analyzed by contextual connection. Both novels employ the coming-of-age genre, sharing ample similarities. However, there are noticeable differences between the two. The current article deals with relationships between the two novels by analyzing the recurrence of the symbol of "Mockingbird". It first deals with protagonists' Losing Innocence, then extends to Social Racism towards the Vulnerable Heroes in both novels, and finalizes with varieties at the end of the day.

In reality, the story was developing in a different color. In contrast, he tried to help her every single time when she asked about it, despite having only one healthy hand. He felt sorry for her as he considered her a tender woman, even though she was a white woman and he was black. It is depicted so delicately that you can feel the atmosphere of that era:

"You did all this chopping and work from sheer goodness, boy?"

"Tried to help her, I says."

Mr. Gilmer smiled grimly at the jury. "You're a mighty good fellow, it seems-did all this for not one penny?"

"Yes, suh. I felt right sorry for her, she seemed to try more'n the rest of 'em-"

"You felt sorry for her, you felt sorry for her?" Mr. Gilmer seemed ready to rise to the ceiling. (Lee, 1960, p. 224)

In that period of time, white people were considered as lords and, in contrast, black people were treated as slaves.

If indulging in "Jasper Jones", Charlie Bucktin describes his feeling as follows: "Everything in my world that was steady and sure and sturdy has been shaken out of place, and it's now drifting and swirling back down in a confetti of debris. A book I knew by heart, torn up and thrown into the air. Everything has been rocked with such rigor and tumult. Everything has been uprooted and broken. A dozen disasters at once. I can't begin to collect the pieces and try to set them as they were. It's like I've got to crawl out of my own eggshell and emerge." [1] The moment described in this quote is the exact time of his witnessing the death of the lost lady, Laura Wishart, who made suicide. It was the opening of his eyes from childhood sleep, becoming an adult, not a boy already! He has no proof, but he knows for sure that Jasper Jones is innocent. However, Charlie sees the only and the first suspect is Jasper Jones. He was arrested and tortured to sign a confession; however, he strongly denied it, as he had nothing to do with her death.

#### Social Racism towards the Vulnerable Heroes

Contextual connections between two novels are especially showcased in the racial discrimination against black people and mixed-race people by white people. It makes the protagonists come out of their shells to look at the world of unfair racial bias through the eyes of adults. As they witness prejudice for the first time, it makes them feel vulnerable, powerless to the extent that they cannot react or penetrate the situation. It makes them look at their lives from different angles. The trial of Tom Robinson ("To Kill a Mockingbird"), for example, made Scout and Jem come of age. "English literature often focuses on interpersonal relationships centered on individual desires, emotional connections, and personal growth. Works like Lee's To Kill a Mockingbird (1960) explore themes of love, friendship, and moral choices, where characters prioritize personal happiness and ethical considerations, showcasing a more individualistic worldview." Lee explores both positive and negative aspects of community influence, showing how social norms can enforce justice or perpetuate prejudice. Because of discrimination, they became older than their peers within a short period of time. Jasper Jones ("Jasper Jones") had no one to rely upon unless Charlie Buchtin. Even though he barely knew Charlie, he had no choice but to trust an almost stranger. However, Charlie's pure eyes and childish, soft heart built trust to share his biggest secret he had ever had. Although Charlie was a white boy, he still seemed to have no racial prejudice.

However, the victim, who made a suicide, is not Jasper Jones but a really lovely lady, girlfriend of him, Laura Wishart. She was a tender rose which could not survive in the society and family where mother, her biological mother, closed her eyes to sexual abuse of her daughter to save her relationship and family with ,Laura Wishart's stepfather. The novel shows how immoral it is to blame peaceful citizens just because of their being colored or mixed race.

Charlie's first observation about Jasper, whom he has never actually met until this moment, is 'people in town say he's dangerous, but I've always wondered what he's really like'. This kind of off-hand comment enforces the engrained belief that Aboriginal people are believed to be 'treacherous beings devoid of mercy or pity' due to the colonial representations of them [4, p. 85]. The protagonist, Charlie, does not believe in the social prejudice, as he never new him or witnessed any wrongdoing from him. Published in 2009, craig silvey's novel Jasper Jones was a public and critical success. as well as being shortlisted for numerous awards, the novel was the overall winner and fiction winner for the indie book of the year (2009), joint-winner in the fiction category of the western australian premier's book awards (2009), the australian book industry awards book of the year and literary fiction of the year (2010), and the university of canberra's book of the year (2013). the novel has been translated into multiple languages and has been well-received internationally. it was selected by the American Library Association as
