## Discussion

Empathy and counseling methods were positively received by all family members, increasing their motivation to participate in counseling and educational processes.

They contribute to stabilizing the family environment, fostering open and constructive communication, and positively influencing children's psychological development. The study demonstrated that systematic and individualized approaches by social pedagogues play a crucial role in resolving family conflicts and enhancing trust and cooperation.

These findings indicate that effective application of empathy and consultative approaches strengthens the professional activities of social pedagogues and ensures social stability within families.
