## RESULTS

Integration of civic engagement opportunities within the curriculum enhances students' understanding of democratic processes and responsibilities. Courses that emphasize critical thinking and debate foster an environment where democratic values can be explored and debated. Inclusion of human rights education in the curriculum aligns with democratic principles and supports students' understanding of their rights and responsibilities. The review also identified gaps in the current research, such as limited studies on the specific impact of higher education practices on democratic development in Mexico.

Most universities incorporate elements of democratic education in their curricula, including courses on political science, human rights, and social justice. However, the depth and focus of these courses vary significantly. Universities with strong community outreach programs and student involvement in local governance demonstrate a positive impact on students' civic engagement. Conversely, institutions with limited engagement activities show less emphasis on fostering democratic values. Political influence,

resource constraints, and social inequality were identified as significant challenges. Political interference often affects academic freedom, while resource limitations impact the quality of civic engagement programs. While many students engage in extracurricular activities related to civic engagement, there is a notable disparity in participation rates among different universities and regions. Both students and faculty identify political influence and social inequality as major barriers to effective democratic education. Faculty members also cite limited resources and administrative support as impediments. Most universities articulate a commitment to fostering democratic values in their mission statements, though the specific strategies for achieving this vary. Strategic plans often include goals related to enhancing civic engagement and promoting social responsibility, but the implementation of these goals is inconsistent.

The results indicate that while Mexican universities are making strides in integrating democratic principles into their educational practices, significant challenges remain. Variability in curriculum design, limited civic engagement opportunities, and external pressures such as political interference and resource constraints affect the overall effectiveness of university education in promoting democratic foundations. Addressing these challenges requires targeted reforms and increased support for universities to better fulfill their role in democratic development.

## DISCUSSION

The literature review and case studies confirm that university education can significantly contribute to democratic values through curriculum design, civic engagement, and the promotion of critical thinking. The integration of democratic principles into educational practices, such as offering courses on political science, human rights, and social justice, is crucial for fostering an informed and active citizenry. However, the disparity in civic engagement opportunities among universities indicates that some institutions may lack the resources or institutional support needed to foster meaningful civic involvement. The differences in civic engagement practices highlight the need for policies that ensure all universities have the capacity to provide these opportunities. Enhancing support for community outreach programs and student involvement in civic activities could help bridge this gap.

Political interference in academic freedom poses a significant threat to the integrity of democratic education. This influence can restrict the scope of academic inquiry and the impartiality of educational content. Limited financial and institutional resources impact the ability of universities to offer comprehensive civic engagement programs and maintain high-quality democratic education. Social disparities affect students' access to democratic education and opportunities for civic engagement. Universities must address these inequalities to ensure that all students have equitable access to democratic learning experiences. To

mitigate the impact of political pressures, universities should advocate for academic freedom and seek to create a neutral educational environment that supports democratic inquiry and debate.

Increasing funding and resources for civic engagement programs and democratic education can enhance the effectiveness of these initiatives. Collaboration between universities, government bodies, and private sector partners may also provide additional support. Implementing targeted programs to support underrepresented and disadvantaged students can help address social inequalities and ensure that all students benefit from democratic education. Aligning educational practices with democratic principles, enhancing civic engagement opportunities, and overcoming barriers such as political influence and resource constraints are essential steps in strengthening the role of higher education in supporting democratic foundations.
